

Club Reptile Terms of Use

Earning Club Reptile Points

To ensure you receive credit for your Club Reptile transactions, please be sure to log in to your account when you visit ReptileChannel.com. Club Reptile Members may track their summary online at www.reptilechannel.com or by subscribing to receive the Club Reptile eSummary(sm). Club Reptile eSummary subscribers receive their summary and information every month, regardless of activity level. Your summary includes points earned, along with newsletters and special promotions.

If your account has no qualifying activity in any 30-day period, all points in the account will expire. Qualifying activity is defined as redeeming any Club Reptile award or accruing points on any eligible Club Reptile activity.

Points will be credited only to the account of the Club Reptile member. Points will be credited within 24 hours of accruals of the points.

Points are redeemable for one account per person. You may have multiple pet profiles, but creating multiple accounts is not allowed.

Except as otherwise explained below, Club Reptile points are not transferable and may not be combined among Club Reptile members, their estates, successors and assigns. Accrued points and awards do not constitute property of the member. Neither accrued points, nor awards are transferable by the member (i) upon death, (ii) as part of a domestic relations matter, or (iii) otherwise by operation of law

Club Reptile points are determined by the activity you participate in and the points are explicitly stated at the point of participation.

Only individual persons are eligible for Club Reptile program membership. Corporations or other entities are not eligible to become Club Reptile members or to accrue Club Reptile points. Only the member named on the account will be entitled to access account information.

Club Reptile Award Conditions

To ensure you receive credit for your Club Reptile transactions, please log in to Club Reptile number when you participate in a Club Reptile activity. ReptileChannel.com in its sole discretion, has the right to change the Club Reptile program rules, regulations, awards and special offers at any time with or without notice. This means that the accumulation of points does not entitle members to any vested rights with respect to such accumulated points, awards or program benefits. In accumulating points or awards, members may not rely upon the continued availability of any award or award level, and members may not be able to obtain all offered awards. Any award may be withdrawn or subject to increased points requirements or new restrictions at any time. ReptileChannel.com may, among other things, (i) withdraw, limit, modify, or cancel any award; (ii) change program benefits, participant affiliations, conditions of participation, rules for earning, redeeming, retaining or forfeiting points, or rules for the use of points ReptileChannel.com reserves the right to end the Club Reptile program with 30 days notice. ReptileChannel.com may amend its rules of the Program at any time without notice. Once points are redeemed for awards, all transactions are final. There are not any returns or exchanges allowed. Income tax liability on Club Reptile awards, if any, is the responsibility of the member.

General Club Reptile Conditions

At no time may Club Reptile points be purchased, sold or bartered. Any such points are void if transferred for cash or other consideration. Violators may be liable for damages and litigation costs, including ReptileChannel.com attorneys fees incurred in enforcing this rule.

ReptileChannel.com reserves the right to audit any and all accounts at any time and without notice to the member to ensure compliance with Club Reptile program rules and applicable conditions. In the event that an audit reveals discrepancies or violations, the processing of Club Reptile awards, points accrual and summaries may be delayed until the discrepancies or violations are resolved satisfactorily to ReptileChannel.com. Pending such resolution, members may be prohibited from redeeming points for a Club Reptile award in ReptileChannel.com's sole discretion.
